

TCAP Assessment Subjects by Grade Accountability, Educator Evaluation, and TVAAS Reporting

The table below provides a snapshot of the Tennessee Comprehensive Assessment Program (TCAP) assessment subjects by grade and the available data across various reporting systems, including school/district accountability, educator evaluation, Tennessee Value-Added Assessment System (TVAAS) reporting, and performance level reporting for the 2022-23 school year. The key highlights are summarized below:

- In 2022-23, for school accountability, the following assessments will be included in the success rate (i.e., cohort success rate) and participation rate calculations:
 - Grades 3 through 8 TCAP English language arts (ELA) and math tests, English II, and Algebra I/Integrated Math I. Exceptions may apply for accelerated students and students taking the alternative assessments.
- In 2022-23, for school accountability, the following assessments will be included in the calculation of TVAAS composites:
 - Grades 3 through 8 TCAP ELA and math tests, Algebra I, Geometry, Algebra II, Integrated Math I, Integrated Math II, Integrated Math III, English I, and English II. Consult the [TVAAS Technical Report](#) for more information regarding TVAAS data preparations and business rules.
- For educator evaluation, TVAAS value-added reports allow teachers, schools, and districts to select data of interest, assess trends over time, and compare results. In 2022-23, data are available for:
 - Grades 3 through 8 and EOC tests in ELA and math subject areas; grades 5 through 8 and EOC Biology I in science subject areas; grades 6 through 8 and EOC U.S. History subject areas.
 - ELA and math teachers from grades 3 through 8 and EOC subject areas, science teachers from grades 5 through 8 and EOC Biology I, and social studies teachers from grades 6 through 8 and EOC U.S. History receive TVAAS composite scores when sufficient data are available to generate a TVAAS composite for educator evaluation purposes.
- Student-level performance data are available in all tested subject areas. In 2022-23, the performance level descriptors are Below Expectations, Approaching Expectations, Met Expectations, and Exceeded Expectations.
