

**Individualized Education Account (IEA) Program Per-Pupil Funding Amounts

The Total Annual Award column is the total amount of IEA funds that IEA account holders will receive for the July 1, 2022–June 30, 2023, school year. The Total Annual Award amount is based on the local educational agency (LEA) in which the student resides and is the net award amount reflecting the deduction of the Tennessee Department of Education's six percent administrative fee.
