

Tennessee Code Annotated, Section 49-10-1306: Isolation and Restraint Data

Incidents of Isolation/Restraint – 2022-23 School Year

Provides a count of *all* isolation/restraint events during the reporting period. The count is based on the number of events, not just the number of students. Accordingly, students with multiple events should be included multiple times.
