# ENFORCEMENT OVERVIEW

- The Division of Solid Waste Management (DSWM) issued four Hazardous Waste Orders and three Solid Waste Orders between January 31, 2024, and May 15, 2024.
- From the previous Board meeting, two orders require an update.

# Orders Issued – Closed

- Fac. ID No. TNR000050146/SkyNano LLC, Knox County.
  - HWM23-0031 Directors Order
  - Signed February 23, 2024.
  - Container labeling and dating, waste stream notification, weekly inspections, employee training, arrangements with local authorities.
  - Civil Penalty \$5,470.00 and Damages \$826.00 were paid April 8, 2024.
  - Case is Closed.
- Fac. ID No. TND987776341/Univ. of Memphis, Shelby County.
  - HWM23-0019 Directors Order
  - Signed February 23, 2024.
  - HW determinations, container labeling and dating, weekly inspections, storage for greater than 90 days, UW handling.
  - Civil Penalty \$4,620.00 and Damages \$466.00 were paid April 12, 2024.
  - Case is Closed.

# Orders Issued – Closed

- Fac. ID No. TND981474539/Institutional Casework, Henry County.
  - HWM23-0026 Directors Order
  - Signed March 26, 2024.
  - HW determinations, container labeling, weekly inspections, employee training, arrangements with local authorities and annual reporting.
  - Civil Penalty \$9,700.00 and Damages \$3,555.00 were paid April 30, 2024.
  - Case is Closed.

# Orders Issued – Signed

  - HWM23-0034 Commissioners Order
  - Signed April 30, 2024.
  - Repeat Permit Violations - containment integrity, employee training, container labeling and handling, exceeding permitted capacity.
  - Civil Penalty \$147,315.00 and Damages \$2,459.00.
  - Within 30-day timeframe.
- Fac. ID No. NRS370000403 /Goins Property, Hawkins County.
  - SWM23-0003 Directors Order
  - Signed February 14, 2024.
  - Unlawful Disposal.
  - Civil Penalty \$6,400.00 and Damages \$1,987.00.
  - Unable to locate Respondent. Property ownership is uncertain.

# Orders Issued – Final

- Fac. ID No. NRS370000403/Parker Property, Hamilton County
  - SWM24-0001 Directors Order
  - Signed April 3, 2024.
  - Unlawful disposal.
  - Civil Penalty \$1,600.00 and Damages \$868.00.
  - Property owner did not respond to the Order.
  - Civil penalty and damages have been referred to Fiscal Services for invoicing.

# Orders Issued – Appealed

- Fac. ID No. SNL800000227 /Smith County Landfill, Hamilton County.
  - SWM24-0007 Directors Order
  - Signed April 5, 2024.
  - Overfill beyond permitted capacity.
  - Civil Penalty \$40,000.00 and Damages \$1,575.00.
  - Appealed May 10, 2024.

# Orders Issued – Update

- Fac. ID No. NRS670000055/Tower Hill Road, Overton County
  - SWM23-0018 Director's Order
  - Signed December 20, 2023.
  - Unlawful disposal.
  - Civil Penalty \$1,800.00 and Damages \$1,725.00.
  - Site covered with gravel and in use as parking area March 21, 2024.
  - Civil Penalty and Damages referred to Fiscal Services May 15, 2024.
- Fac. ID No. TND063778377/Signal Plating Inc., Hamilton County.
  - HWM23-0018 Directors Order
  - Signed January 18, 2024.
  - HW determinations, waste stream notifications, reporting and record keeping, weekly inspections, employee training.
  - Civil Penalty \$25,400.00 and Damages \$2,629.80 were paid February 20, 2024.
  - Case is Closed.
