Tennessee State Parks has an outstanding opportunity to work in a regional capacity with our state parks. This position is a project manager responsible for all aspects of major maintenance for multiple parks including construction oversight, and project execution. The position handles major maintenance for multiple parks for contracted maintenance, staff and management.

Extensive knowledge of construction techniques, materials, and quality control is necessary. The preferred candidate will have a minimum of 5-years commercial construction experience and possess a building related trade license, i.e., electrical, plumbing, mechanical, or a general contractor. Highlighted Responsibilities:

- Responsible for all aspects of project management including identifying need, developing scope, obtaining bids, construction quality control and assurance, and project closeout.
- Estimate cost of repairs and materials observing repair costs guidelines to complete projects.
- Prepare detailed project specifications.
- Develop relationships and technical assistance to park managers and staffs.
- Assist park maintenance staffs with technical training.
- Guide maintenance staff to ensure all machinery, vehicles and equipment are maintained and kept in good condition.
