This position is responsible for custodial work of average difficulty, which includes leading others and performs related work as needed. We are seeking someone who is comfortable interacting with guests of the park and providing quick response to their custodial needs. The preferred candidate will have some custodial experience. The position requires the ability to work on some weekends and holidays. The preferred candidate will have a High School Diploma or GED. ### **Highlighted Responsibilities:**

- Operate vehicles, mechanized devices, or equipment.
- Operate a variety of custodial related tools and equipment including floor washing machines, floor buffers, and vacuums.
- Move furniture as needed for cleaning.
- Perform or lead others in performing duties such as sweeping, mopping, scrubbing, stripping, waxing and buffing floors.
- Clean restrooms by sanitizing toilets, cleaning sinks, washing floors and walls, sanitizing showers, cleaning mirrors, and emptying trash. Clean and sanitize showers.
- Remove trash from the grounds surrounding the facilities.
- Keep simple records and makes routine reports of repairs or supplies needed in the facilities. Perform light maintenance of the equipment utilized.
