

**NOTICE OF INTENT TO REISSUE
HAZARDOUS WASTE MANAGEMENT CONTAINER STORAGE PERMIT
CLEAN HARBORS TENNESSEE, LLC**

The Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) has tentatively decided to reissue a hazardous waste container storage permit to Clean Harbors Tennessee, LLC (Clean Harbors) for the Hazardous Waste Storage facility. The Clean Harbors Tennessee, LLC Hazardous Waste Storage facility (EPA ID TND000645770) is located at 2815 Old Greenbrier Pike in Greenbrier, Robertson County, Tennessee 37073. **TDEC invites the public to submit comments on this proposal during a 45-day comment period ending on September 6, 2024.**

The current permit, TNHW-144, was issued on September 15, 2010, and was effective for ten years. Clean Harbors requested a renewal application extension on March 10, 2020, and submitted the renewal application on May 29, 2020. The approvals of the extension request and submittal on May 29, 2020, allow continued operations under the existing permit pending a final decision being made on the application. Clean Harbors held a pre-application public meeting on May 21, 2020, as announced in the April 21, 2020, edition of the Robertson County Connection. The meeting was held in a "virtual" format with one attendant, and no oral or written comments were received.

The current permit addresses the treatment and storage of RCRA hazardous waste at the facility. The current permit allows the facility to store a total maximum capacity of 200,000 gallons of hazardous waste in four units and the maximum quantity of hazardous waste that may be treated at the facility by blending is 20,000 gallons/day. If the renewal permit is approved, Clean Harbors will continue the operation of the current storage units with the same storage capacity; however, there will be no treatment of hazardous waste at the facility.

Based on the review of the application, and as authorized pursuant to Tennessee Rule 0400-12-01-.07(7), DSWM has determined the application to be complete and has prepared a draft permit. DSWM proposes to issue the permit under the authority of the Tennessee Hazardous Waste Management Act of 1977, as amended, Tennessee Code Annotated, Section 68-212-101 et seq., and Rule Chapter 0400-12-01, Hazardous Waste Management. In accordance with Rule 0400-12-01-.07(7)(e), this notice requires a 45-day comment period, beginning on the date of this publication, and the opportunity to request a public hearing. A fact sheet, which provides additional information about the site and the proposed permit, has been prepared. Pending consideration of any contrary information received, it is the present intent of DSWM to issue this permit. If issued, the permit would be effective for ten years.

A public hearing will be held on August 26, 2024, at the Greenbrier City Hall located at 2414 Hwy. 41 South, Greenbrier, TN 37073 as well as via video teleconference. Information on how to join online is provided below. An information session will be held from 5:30 p.m. to 6:00 p.m., CDT for the public to inspect the draft permit with representatives from Clean Harbors and TDEC. The formal hearing will begin at 6:00 p.m., CDT with a presentation from TDEC on the renewal permit. After the presentation, TDEC will receive oral comments from the public that will be recorded. The public may submit written comments at the meeting.

After considering all comments, DSWM will make a final decision to either issue or deny the permit. Notice will be given to the applicant and each person who has submitted written comments or requested notice of the final decision. At the time a final decision is issued, a Response to Comments document addressing all significant input received on the draft permit will be made available to the public. The final decision shall become effective upon signing by the Director of DSWM.
