

## Sevier Solid Waste Inc. Demolition Landfill Major Modification Approved

The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has issued a permit major modification to Sevier Solid Waste Inc. The facility, identified as the Sevier Solid Waste Inc. Class III Landfill (DML780000126), is located in Sevier County at 2106 Ridge Road, Pigeon Forge, Tennessee.

This permit authorizes construction, operation, closure, and post-closure care of the Class III disposal facility for waste materials classified as demolition/construction wastes, farming wastes, landscape wastes, dry compost plant residuals, and certain wastes having similar characteristics as approved in writing by TDEC. No hazardous wastes, as regulated by the Tennessee Hazardous Waste Management Act (Tennessee Code Annotated, Section 68-212-101, et. seq.) and the Rules adopted pursuant to the Act, shall be accepted for disposal at this facility.

DSWM made the draft of this permit available for review during a 45-day public comment period which ended on October 9, 2023. DSWM received no oral or written comments during the above-mentioned public comment period.
