**BOARD OF MEDICAL EXAMINERS**

Licensee: Todd F. Brooks, M.D., Lic No. 13157, Memphis  
Violation: Respondent practiced medicine when he was mentally or physically unable to safely do so  
Action: Respondent must undergo an evaluation by a Tennessee Medical Foundation approved provider as well as a comprehensive fitness to practice and neuropsychological evaluation by July 24, 2022. The evaluation findings will determine the type of encumbrance that will be placed upon the Respondent's license. An update will follow. Respondent was assessed a one thousand dollar (\$1,000) civil penalty and costs

Violation: Failed to timely renew certification and practiced on a lapsed certification  
Action: Certification reprimanded, assessed nine hundred dollar (\$900) civil penalty and costs not to exceed two thousand dollars (\$2,000)

Licensee: Benjamin F. Evans, M.D., Lic No. 19874, Memphis  
Violation: Respondent failed to timely sign two (2) death certificates  
Action: The Respondent's medical license was reprimanded, and he was assessed a two hundred dollar (\$200) civil penalty and costs

Licensee: Yogeshwar Gill, M.D., Lic No. 44100, Manchester  
Violation: Licensee was the subject of a state or federal indictment for an offense that involves a controlled substance or sexual offense. As such, the Licensee's authority to prescribe Schedule II Controlled Substances was automatically suspended  
Action: Licensee's authority to prescribe Schedule II Controlled Substances is suspended

Violation: Unprofessional, dishonorable or unethical conduct; Habitual intoxication or personal misuse of any drugs or the use of intoxicating liquors, narcotics, controlled substances, controlled substance analogues or other drugs or stimulants in such manner as to adversely affect the person's ability to practice medicine; Engaging in the practice of medicine when mentally or physically unable to safely do so  
Action: License summarily suspended

Violation: Failed to timely renew certification and practiced on a lapsed certification  
Action: Certification reprimanded, assessed two thousand nine hundred dollars (\$2,900) in civil penalties and costs not to exceed one thousand dollars (\$1,000)
- Licensee: Hau La, M.D., Lic. No. 42545, Brentwood  
Violation: Licensee was the subject of a federal indictment for an offense that involves a controlled substance violation. As such, the Licensee's authority to prescribe Schedule II Controlled Substances was automatically suspended  
Action: Licensee's authority to prescribe Schedule II Controlled Substances is suspended
- Licensee: Matthew Hine, M.D., Lic No. 45249, Chattanooga  
Violation: Unprofessional, dishonorable or unethical conduct; Habitual intoxication or personal misuse of any drugs or the use of intoxicating liquors, narcotics, controlled substances, controlled substance analogue or other drugs or stimulants in such manner s to adversely affect the person's ability to practice medicine; Engaging in the practice of medicine when mentally or physically unable to safely do so  
Action: License suspended until Respondent can obtain Tennessee Medical Foundation ("TMF") advocacy. Once proof of advocacy is provided, license placed on probation for a period of three (3) years. Costs not to exceed twenty-five thousand dollars (\$25,000) to be paid in 60 days
- Licensee: James H. McElmurray III, M.D., Lic No. 41403, Mount Pleasant, SC  
Violation: The Respondent's conditional medical license required him to maintain Tennessee Medical Foundation advocacy for five years. The Respondent relapsed and the Tennessee Medical Foundation withdrew advocacy in December 2021  
Action: The Respondent voluntarily surrendered his medical license. A voluntary surrender has the same effect as a revocation. The Respondent was also assessed costs
- Licensee: Brent Sheldon Neal, M.D., Lic No. 38563, New Tazewell  
Violation: Respondent routinely failed to timely sign death certificates  
Action: The Respondent's medical license was reprimanded, and he was assessed a one hundred dollar (\$100) civil penalty and costs
- Licensee: Dagoberto Rodriguez, M.D., Lic No. 59048, Deerfield Beach, FL.  
Violation: Disciplinary action against the licensee to practice medicine by another state or territory of the United States for any acts or omissions that would constitute

grounds for discipline of a licensee licensed in this state. A certified copy of the initial or final order or other equivalent document memorializing the disciplinary action from the disciplining state or territory shall constitute prima facie evidence of a violation of this section and shall be sufficient grounds upon which to deny, restrict or condition licensure or renewal and/or discipline a licensee licensed in this state

Action: License reprimanded; Three (3) Type C penalties totaling three-hundred dollars (\$300). Costs not to exceed five thousand dollars (\$5,000) to be paid in 30 days

Violation: Unprofessional, dishonorable or unethical conduct; violation or attempted violation, directly or indirectly, or assisting in or abetting the violation of, or conspiring to violate any provision of this chapter or, any lawful order of the board issued pursuant thereto or any criminal statute of this state; making false statements or representations, being guilty of fraud or deceit in obtaining admission to practice or being guilty of fraud or deceit in the practice of medicine

Action: License placed on probation for a period of time to run concurrent with his 5-year TMF contract, or extension thereof, continued monitoring through the West Virginia Physician's Health Program (WVPHP) through at least June 30, 2022 whereby he must comply with any and all recommendations of the WVPHP and maintain advocacy of the WVPHP for the duration of his contract or extension thereof, quarterly reports must be submitted detailing compliance with monitoring contract, must maintain good and lawful conduct during period of probation, shall not prescribe opioids for at least six (6) months and until successful completion of a prescribing course and during this time when he is restricted from prescribing opioids he shall not collaborate with any advanced practice registered nurses or physician assistants for issuing opioids, must provide proof that he has notified any physicians, podiatrists, advanced practice registered nurses, or physicians assistants with whom he collaborates of the discipline, must complete an ethics boundaries and professionalism course, assessed two thousand three hundred dollars (\$2,300) in civil penalties, and costs not to exceed one thousand two hundred fifty dollars (\$1,250)

Violation: On October 7, 2021, Respondent prescribed ten Xanax pills to a colleague without establishing a physician-patient relationship or creating a medical record

Action: The Respondent's medical license was reprimanded. The Respondent is required to complete a prescribing controlled drugs course and he was assessed a six hundred dollar (\$600) civil penalty and costs

Following payment of civil penalty and a successful reinspection, clinic may apply to terminate probation

 Violation: Operating a pain management clinic prior to obtaining a license  
 Action: Reprimand and civil penalties totaling eighty-two thousand dollars (\$82,000)
