Discussion/Clarification of Staff Correspondence/Inquiries

1. Mr. Gowen spoke about the existing training permit application and the included question soliciting voluntary disclosure of any criminal background. Any information disclosed is not acted upon by the central office; thus, the question of relevance is asked.

Legal counsel's opinion is there is no authority to act upon any positive indication;

thus there is no reason to ask the question. In addition, the question and the response is between the school and the clinical affiliation.

Move to remove the criminal background question from the training permit application: Ms. Walton

2. There was an inquiry from Amy O. Cox, Southwest Tennessee Community College, regarding Rule 1200-06-02-.02(2)(c)(ii) and the application of the student/teacher ratio.

Ms. Cox was not in attendance to speak to the committee.

The Committee stated the rule was clear regarding the student/teacher ratio and took no action.

3. Ms. Walton introduced a discussion regarding the scope of practice for medical laboratory technicians as it pertains to the calibration of analytical instruments. At present, the scope of practice for licensed MLTs does not include the calibration of analytical instrumentation; however, equipment evolution and advances to include the simplification of calibration processes, the question arises, "Should the calibration of some or all analytical instruments be included within the scope of practice for MLT licensees?"

With a rewrite of the personnel rules scheduled in August, 2014, the following motion was offered:

Move to request the rules re-write committee include, in the medical laboratory technician scope of practice, performance of calibrations on clinical and point of care instruments, when and if those calibration procedures do not require sample manipulation beyond thawing of the calibration materials and/or simple reconstitution of the same materials; and where there are no procedures and or possibilities for user intervention(s), to include mathematical manipulations of the slope and/or intercept of the calibration curve. Motion to send to the rules re-write committee approved.

(Ms. Walton, sponsor of this topic, abstained from voting)

4. Representatives from Metropolitan Nashville General Hospital Clinical Laboratory and for Dr. Robert Burnette, Clinical Laboratory Director of same, asked for guidance and direction regarding the possible performance and reporting, via the Laboratory Information System (LIS), certain waived POC tests in the emergency department by facility employed phlebotomy personnel.

After discussion of the issues presented, a decision was made to send this topic and related questions/concerns to the table until the October 15, 2014, meeting. Advisory counsel was requested to research the question and its ramifications, along with any related, previous questions/decisions in order to advise Committee members as it responds to this inquiry.

Other Business:

There was general discussion regarding the rule re-write scheduled for August, 2014. **There was no business conducted and there were no motions made.**

No other business came before the Personnel and Education Committee of the Tennessee Medical Laboratory Board.
